

Please read the following information from State President Darlene Trusty regarding voting at the convention. I will open this as an item for discussion under new business at the April 20 meeting. If you are unable to attend, please email or call me with your thoughts.

"There is an amendment to raise dues \$15 that was proposed by a member. There is a special voting procedure for the increase of dues. There must be a two-thirds vote for this increase to happen. This proposed standing rule will be discussed at the convention. Each chapter president or her official representative (who must be present) shall be entitled to cast one vote for each five active or reserve members. The vote of the chapter may be divided. Please take time to find out how your members feel about the increase in dues. You or your official representative will vote accordingly using this information and the information from the discussion at the convention. It is important that you or your representative is present so that you or your representative will hear the discussion of the attached proposed standing rules as there may be an amendment to just increase dues \$5."
